#### 1. Main Themes

This conference will look at multi-level governance. In decentralization, better local governance is closely intertwined with national competitiveness, leading to improved efficiency and transparency. Especially the capacity and ability of local authorities to deliver efficient public service are very crucial. Developing solid public management tools, which fit in the locality, will be one of main challenges for them.

On the other hand, the multi-level governance is also the issue of a whole-ofgovernment. The role of the central governments can be re-defined in the new intergovernmental relationship; how to help ensure the local governments' capacity to manage public policy responsibilities. In addition, the relations among central governments can be also considered in the context of multi-level governance.

### 2. Conference Objectives

- Explore proactive solution for creative relations among multi-level governments to enhance government's trust
- Redefine roles and responsibilities of multi-level governments in capacity building, finance, ICT use, and conflict resolutions.
- Promote dialogue about creative intergovernmental relationship by sharing concrete cases among the OECD member and non-member countries
- > Disseminate the results to government officials and experts in public governance

#### 3. Structure of the Conference

This conference begins with opening remarks by the host organisations. The keynote presentation will be made by Dr. Alex Brillantes JR, Deputy SG of EROPA, and Dr. Ginandjar Kartasasmita, Spokesperson, Regional Representatives Council of Indonesia. They will provide an insightful perspective and steps ahead for creative intergovernmental relations to ensure government's trust.

The conference consists of four different plenary sessions and conclusions : (1) Strengthening the Capacity of Local Government in Intergovernmental Relations; (2) Financing Local Development through Intergovernmental Transfer; (3) Improving ICT use across Levels of Government; and (4) Enhancing Conflict Resolution Strategies and Cooperation among Government Organisations. At each session, the chair will raise key issues to be discussed, followed by the brief introduction of presenters. Three presenters will make a presentation for about 25 minutes respectively. Then, all participants are invited to discuss the ideas presented. We may consider the questions below.

# Session 1: Strengthening the capacity of local government in intergovernmental relations

- ✓ Which capacities are critical for the local governments?; In which areas do they need cooperation with central or other local governments?
- $\checkmark$  What are the main challenges the local governments face in strengthening capacity?

#### Session 2: Financing local development through intergovernmental transfer

- ✓ Do local governments have independence and flexibility in setting priorities without transfer dependency?; How does local public funding affect local development?
- $\checkmark$  What are the financial tools and innovations in local development?

#### Session 3: Improving ICT use across levels of government

- $\checkmark$  How wide is the digital divide among levels of government? ;
- ✓ What are the challenges to integrate and standardize public service systems?
- ✓ How do national administrative simplification strategies affect the local levels of government to develop e-government?

#### Session 4 : Enhancing conflict resolution strategies and cooperation among

government organisations

✓ What are the roles and responsibilities of multi-level governments in enhancing conflict resolution and cooperation? ; Are checks and balances mechanisms working among government organisations?

The closing session- Future Steps and Conclusions- will be chaired by Dr. Asmawi Rewansyah, Chairman of the NIPA, to wrap up the conference and highlight the main concerns and steps forward. The chairpersons from each session (1-4) will summarize main results based on the discussion.
