OBJECTIVES

The meeting brings together practitioners, policy makers and researchers with expertise in the field of regulatory policy and enable in-depth discussions in a closer setting; serving as a platform for opportunity to strengthen cross-border networks among the experts and public officials.

The objective of the event is to provide an open and participatory platform for the Asia-Pacific countries to stimulate discussions on how to enhance the quality of regulations for competitiveness and better economic and social outcomes. More specifically, participants will be able to (a) exchange experiences and discuss public governance issues in regulatory reform in their countries for mutual learning among policy makers, (b) deepen understanding of current status and trends of regulatory policies, and (c) develop and strengthen areas for collaboration.

BACKGROUND

Globalization has brought about more intense competition. Countries around the world face similar problems that call for better regulatory tools, institutions and policies that help to create the conditions for entrepreneurship, sustainable employment, higher productivity and good governance.

Recognizing such need, the PGP has launched APG Forum on Regulatory Reform to be held on a regular basis for in-depth policy discussions to deepen understanding of regulatory reform as a vector for stimulating economic productivity and growth.

The annual meeting series bring together experts and delegates for in-depth discussions. The APG Forum on Regulatory Reform: Improving Regulatory Policy for Balanced Economic Growth held in Korea last year was well received as it has stimulated the discussion of regulatory reform in the issues of governance by looking at the background and significance of regulatory policy, regulatory reform for balanced growth and economic stimulation, stakeholder engagement and the socio-economic impact of regulations.

Previously in his position, Mr. Gil served as a Minister to the Embassy of the Republic of Korea in Belgium and as a representative of Korea to the OECD Working Group on Regulatory Reform.

Dato' Abdul Latif Hj. Abu Seman is currently the Deputy Director General, Malaysia Productivity Corporation, Petaling Jaya. 




Ms. Nattanun Asawalertsak

Punita Nook Naidu is the Director of Technical Standards and Compliance of National Water Services Commission of Malaysia. She started her career with managing the quality control of the production line and later took lead in setting up the ISO system for the company as Quality Engineer. Currently she is in the regulatory sector as she manages and oversees 12 units of certifying agencies offices nationwide with 150 offices involved in processing of about 45,000 to 55,000 applications annually.
